

Who can apply?

Participants in the Mentoring Program, both mentors and mentees, must be members of the Law Society of NSW.

Mentees must also be under the age of 36 or in their first five years of practice.

Mentors must be experienced lawyers willing to provide encouragement and advice on a voluntary basis for approximately one hour a month for a one year period.

What's involved?

The Mentoring Program starts at the beginning of the year. There is an initial information session and a dinner to introduce mentors and mentees.

Throughout the year a mentor and mentee are expected to meet regularly to discuss predefined issues. The Program Coordinator is available to assist with any questions or issues that may arise.

At the end of the Program participants are invited to provide feedback. A mentoring relationship may continue after this if agreed by the parties.


