PRIVACY STATEMENT

COLLECTION, USE AND DISCLOSURE OF PERSONAL INFORMATION

The Law Society of New South Wales ("the Law Society") deals with the collection, security, quality, use and disclosure of personal information in accordance with the *Privacy Act 1988* (Cth).

Collection and Use of Personal Information – Information provided by you to the Law Society will be used by the Law Society in order to fulfil all of its functions under the *Legal Profession Act 2004* ("the Act") and associated regulations. Information provided by Members of the Law Society will also be used to maintain membership records, provide information and enable Members to access the services and benefits available to Members of the Society and to conduct research in order to identify and analyse the ongoing needs of Members. The Law Society Council has approved the commercial use of the membership mailing list (including e-mail addresses) in a controlled manner to outside bodies proposing appropriate mail-outs. If, as a Member of the Law Society, you wish to have your name excluded from these commercial mailing lists, you should advise the Law Society Registry in writing.

Disclosure of Personal Information – Information provided by you to the Law Society may be disclosed to the Office of the Legal Services Commissioner; NSW Young Lawyers, subsidiary companies of the Law Society including The College of Law Pty Limited and LawCover Pty Limited, regulatory bodies in other states and/or foreign countries; regional Law Societies and premium funders.

Access to Personal Information held by The Law Society – You have the right to request access to any information held by the Society, which relates to you. You also have the right to request the correction of any information which relates to you and is inaccurate. Any corrections should be advised to the Law Society Registry in writing.
