CALL FOR BAN ON FUR IMPORTS FROM UNREGULATED JURISDICTIONS

The NSW Young Lawyers Animal Rights Committee (the Committee) is part of NSW Young Lawyers, a voluntary organisation and division of the Law Society of New South Wales. The Committee consists of lawyers and law students interested in animal welfare and laws regulating the treatment of animals.

The Committee believes that the animal abuse that occurs in Chinese fur farms is one of the most extreme examples of animal cruelty worldwide. In its 2005 report Fun Fur? A report on the Chinese fur industry Swiss Animal Protection states:

"Conditions on Chinese fur farms make a mockery of the most elementary animal welfare standards. In their lives and their unspeakable deaths, these animals have been denied even the most simple acts of kindness. Instead, millions of individuals are forced to endure the most profound indifference to their suffering, dignity and most basic needs – in the name of fashion ... China's colossal fur industry routinely subjects animals to housing, husbandry, transport and slaughter practices that are unacceptable from a veterinary, animal welfare and moral point of view." We are of the view that the Australian Government should not support the cruel practices undertaken in Chinese fur farms by allowing the products of this cruelty to be imported into Australia.

The Committee is extremely disappointed that the Australian Government is unwilling to consider the "non-economic" impacts of the Australia - China Free Trade Agreement (FTA) presently being negotiated. In light of this unwillingness, the Committee urges you to implement a total ban on fur imports from unregulated jurisdictions, such as China.

Section 50(2) of the *Customs Act 1901* (Cth) allows the Governor General to prohibit the importation of goods into Australia from a specified place, in specified circumstances or unless specified conditions or restrictions are complied with. The Committee calls on you and your Department, to use these powers to ban the importation of fur from jurisdictions such as China, where animal cruelty is rampant.
