Re: Notification of action taken by the SDRO

The Law Society's Criminal Law Committee (Committee) has asked that I write to you in relation to the State Debt Recovery Office's (SDRO) notification requirements under the Fines Act 1996.

The SDRO has the power to suspend or cancel driver licences and cancel vehicle registrations for fine default.

Sections 66(4) and 67(3) of the Fines Act 1996 provide that the SDRO may notify the fine defaulter of the enforcement action to suspend or cancel a driver licence, or to cancel the vehicle registration. However, the sections provide that a failure to notify the fine defaulter does not affect that action.

It is a serious matter for a person to lose their licence or to have their registration cancelled, and it is important that the driver is aware of the action taken. If a driver is unaware of the action taken they unknowingly risk committing an offence of driving while suspended or cancelled, driving unregistered, and driving uninsured. Committee Members are particularly concerned for their clients who are charged with driving whilst licence suspended as a result of fine default when the client was unaware of the licence suspension.

The Committee suggests a legislative amendment to the Fines Act 1996 to place a positive requirement on the SDRO to inform the person of the action taken by way of registered mail.

Such a requirement would not have significant cost implications for the SDRO, and would greatly increase the likelihood that the driver is aware of the action taken.
