Bahá'í and the Right to Education

I write to respectfully urge that the Iranian Government ensure that the human rights of all people, including the Bahá'í, are respected, protected and fulfilled, in accordance with Iran's international human rights obligations.

Bahá'í and the Right to Education

The NSW Young Lawyers Human Rights Committee (HRC) has recently become aware of concerning reports indicating breaches of the human rights of Bahá'í in Iran. Specifically, we are extremely troubled by reports that Bahá'í students are being prevented from attending university and by the recent arrests of those involved in the Bahá'í Institute for Higher Education (BIHE).

NSW Young Lawyers is made up of law students and legal practitioners who are in their first 5 years of practice or under the age of 36. The HRC is concerned with a range of human rights issues both in Australia and abroad and aims to raise awareness and provide education to the legal profession and the wider community on these issues.

We understand from media reports that on 22 May 2011 Iranian authorities raided 30 homes and arrested 16 Bahá'ís involved with BIHE. We are concerned that many of those arrested are still in prison simply for being a part of an initiative which provides higher education to those otherwise denied access to Iranian Universities. We note that the Security General of the United Nations, His Excellency Ban Ki-moon, has raised serious concerns about the treatment of Bahá'ís and other minority groups.

We wish to highlight that as a country that has ratified the International Covenant on Civil and Political Rights, Iran has an obligation to ensure that all people in its jurisdiction enjoy the following:

- · Freedom from discrimination, including on the basis of religion (Article 2);
- Freedom from arbitrary arrest or detention (Article 9);
- Equality before the law and minimum procedural safeguards in criminal prosecutions (Article 14); and
- Freedom of thought, conscience and religion (Article 18).

Importantly also, Iran has ratified the International Covenant on Economic, Social and Cultural Rights, which recognises "the right of everyone to education" and that "higher education shall be made equally accessible to all, on the basis of capacity. We ask Iran to uphold these universal human rights so that higher education is accessible by all people in Iran, irrespective of thought, conscience or religion. The current persecutions against the Bahá'ís on the basis of their religion is a direct violation of Iran's international human rights obligations under these treaties. We urge the Iranian Government to ensure that the human rights of all people, including the Bahá'ís, are respected, protected and fulfilled.
