Schedule 1—Modifications of the National Redress Scheme for Institutional Child Sexual Abuse Act 2018

1 Disapplication of paragraph 19(2)(a)

Paragraph 19(2)(a) of the *National Redress Scheme for Institutional Child Sexual Abuse Act 2018* does not apply, to the extent that it requires a signature of a person or the witnessing of a signature, for the period starting on 1 March 2020 and ending on 31 December 2020 in relation to:

- (a) an application made under section 19 of that Act during that period; or
- (b) an application made under that section before the start of that period if the application is dealt with during the period.

2 Disapplication of paragraph 19(2)(d)

Paragraph 19(2)(d) of the *National Redress Scheme for Institutional Child Sexual Abuse Act 2018* does not apply, to the extent that it requires a signature of a person or the witnessing of a signature, for the period starting on 1 March 2020 and ending on 31 December 2020 in relation to:

- (a) an application made under section 19 of that Act during that period; or
- (b) an application made under that section before the start of that period if the application is dealt with during the period.
