The Family Law Settlement Service (FLSS)

Details: The Family Law Settlement Service (FLSS) is a mediation program, administered by the Law Society of New South Wales' Alternative Dispute Resolution department, suitable for family law matters (financial and property disputes as well as parenting matters).

The FLSS offers a five-hour mediation session (including a two-hour preliminary conference – one hour per party - and a three-hour mediation session) conducted by an accredited mediator with experience in family law.

The mediator's fee is refundable if a party withdraws prior to the preliminary conference. However only \$412.50 per party is refundable should the matter be withdrawn after the preliminary conference, but before the mediation. In all cases the administration fee is retained by The Law Society of New South Wales.

Details: The Law Society Mediation Program offers a four-hour mediation session (including a one hour preliminary conference for both parties and a three-hour mediation) conducted by a nationally accredited solicitor-mediator with expertise in the relevant area of law.

The mediator's fee is refundable if a party withdraws prior to the preliminary conference. However only \$330.00 per party is refundable should the matter be withdrawn after the preliminary conference, but before the mediation. In all cases the administration fee is retained by The Law Society of New South Wales.
