## Draft Conveyancers Licensing Regulation 2021

The Law Society of NSW welcomes the opportunity to comment on the draft Conveyancers Licensing Regulation 2021 ("Regulation"). The Law Society's Property Law Committee has contributed to this submission.

We broadly support the remake of the Regulation as proposed. However, we have two comments, as set out below, on the proposal to introduce penalty notices, and potential changes to the scope of what constitutes conveyancing work.

## 1. Introduction of Penalty Notices

We have concerns with the proposed introduction of penalty notices for breaches of the Rules of Conduct under the Regulation. In our view, the current process of investigations and sanctions under Part 9 of the *Conveyancers Licensing Act 2003* ("Act") provides an appropriately rigorous response to breaches of the Rules of Conduct. Issuing penalty notices may be perceived as being less of an administrative burden, but such notices may have the unintended consequence of diluting the impact of the existing, more formal, sanctions. Additionally, Part 9 of the Act currently permits the imposition of a monetary penalty for breaches of the Rules of Conduct under s 133(1)(d) of the Act. We are not persuaded that a penalty notice regime is necessary or appropriate.

## 2. The scope of 'conveyancing work' under s 4

The Law Society supports the current definition of 'conveyancing work' under s 4 of the Act. In our view the current definition appropriately describes the scope of conveyancing work.

We note that question 10 of the Regulatory Impact Statement seeks feedback on whether "any other work be expressly included in, or excluded from, 'conveyancing work' that can be carried out by licensed conveyancers". We further note that no specific proposals are suggested in the Regulatory Impact Statement, other than perhaps a clarification in relation to powers of attorney. Should any specific proposals to extend the scope of conveyancing
