# LEGAL PROFESSION UNIFORM LAW (NSW) INSTRUMENT OF DELEGATION

# PROFESSIONAL STANDARDS

Pursuant to section 32 of the Legal Profession Uniform Law Application Act 2014 (NSW) (Application Act), the Law Society Council (the Council) delegates to the DIRECTOR, LEGAL REGULATION OF THE LAW SOCIETY OF NEW SOUTH WALES the following functions (including powers, authorities and duties):

# **Practising Certificates**

- To reject an application for renewal of a practising certificate made during the late fee period or made outside the standard renewal period or late fee period pursuant to section 37(3) of the Application Act;
- 2. To grant or renew an Australian practising certificate pursuant to sections 44 and 45 of the Legal Profession Uniform Law (NSW) (**Uniform Law**);
- 3. To reject a notification of principal place of practice pursuant to section 46(2) of the Uniform Law;
- 4. To determine conditions on a practising certificate pursuant to section 47 of the Uniform Law;
- 5. To impose discretionary conditions on a practising certificate pursuant to section 53 of the Uniform Law save and except for the power to impose discretionary conditions on a practising certificate in relation to conditions of the kind specified in rule 16(c) to (g) of the *Legal Profession Uniform General Rules* 2015 (Uniform General Rules);
- 6. To alter a practising certificate or issue a substitute practising certificate to reflect a variation under the Uniform Law pursuant to section 55 of the Uniform Law;

# **Registration Certificates**

- 7. To grant or renew an Australian registration certificate pursuant to section 62 of the Uniform Law;
- 8. To reject a notification of principal place of practice pursuant to section 63(2) of the Uniform Law;
- 9. To impose discretionary conditions on an Australian registration certificate pursuant to section 67 of the Uniform Law save and except for the power to impose discretionary conditions on a registration certificate in relation to conditions of the kind specified in rule 16 (c) to (g) of the Uniform General Rules;

# Variation, suspension or cancellation of certificates

- 10. To vary a certificate for a formal or clerical reason or in another way that does not adversely affect the holder's interests pursuant to section 74(1) of the Uniform Law;
- 11. To vary, suspend or cancel a certificate at the request of or with the concurrence of the holder pursuant to section 74(2) of the Uniform Law;
- 12. To vary, suspend or cancel a certificate at the direction of the designated tribunal under s.302 pursuant to section 75 of the Uniform Law;
- 13. To form the belief that a practising certificate should be varied (amended), suspended or cancelled by the Council on a ground specified in section 82 of the Uniform Law and give the holder of the certificate notice under section 83 of the Uniform Law of the proposed action;

# Show cause events

- To issue a notice in relation to a designated show cause event pursuant to section 90 of the Uniform Law.
- 15. To receive a written statement of a show cause event pursuant to section 91 of the Uniform Law;
- 16. To determine to take no action pursuant to section 93 of the Uniform Law;

# **Giving Notices**

- 17. To give notice pursuant to section 81 of the Uniform Law;
- 18. To give notice pursuant to section 83 of the Uniform Law;
- 19. To give notice pursuant to section 94(3) of the Uniform Law;
- 20. To give notice pursuant to section 95 of the Uniform Law;

# Trust money and trust accounts

- 21. The power to receive written notices of irregularity referred to in section 154(2) of the Uniform Law;
- 22. The function under section 155 of the Uniform Law, if not satisfied that a law practice has had the law practice's trust records externally examined as required by section 155 of the Uniform Law or

that an external examination of the law practice's trust records has been carried out in accordance with the Uniform Rules, to appoint a suitably qualified person as an external examiner to examine the law practice's trust records;

23. The power to receive from an investigator the written report of an investigation referred to in section 165 of the Uniform Law;

24. To carry out the functions of the Council pursuant to section 437 of the Uniform Law.

25. To issue a certificate pursuant to section 446 of the Uniform Law;

# Savings and transitional issues

- 4. Claims against the Legal Practitioners Fidelity Fund are to be determined by the Management Committee of the Legal Practitioners Fidelity Fund independently, at arm's length from the legal profession.
- 5. Pursuant to section 119(1) of the Legal Profession Uniform Law Application Act 2014 and s.426(1) of the Legal Profession Act 2004 as applicable, the Council delegates to the Management Committee of the Legal Practitioners Fidelity Fund as constituted from time to time so much of the functions previously delegated by the Council to the Management Committee of the Legal Practitioners Fidelity Fund in paragraph numbered 3 of its resolution made on 15 January 2015 (attached) as are necessary to give effect to clauses 22(2) and 2(5) of Schedule 4 of the Legal Profession Uniform Law (NSW) to deal with claims in accordance with the Legal Profession Act 2004.
- 6. # Preamble: the role of the Council of the Law Society of New South Wales under the Legal Profession Uniform Law (NSW)

The Council of the Law Society of New South Wales (**Law Society Council**) is a designated local regulatory authority under the *Legal Profession Uniform Law* (*NSW*) (**Uniform Law**).

A designated local regulatory authority means "a person or body specified or described in a law of this jurisdiction for the purposes of a provision, or part of a provision, of this Law in which the term is used" (s6 of the Uniform Law).

The Uniform Law confers powers and functions on designated local regulatory authorities.

Section 11 of the *Legal Profession Uniform Law Application Act* (**Application Act**) sets out the provisions under the Uniform Law for which the Law Society Council is the designated local regulatory authority such as Chapters 2 to 4 and 6 to 8.

The Council of the Bar Association of New South Wales and the New South Wales Legal Services Commissioner (**NSW Commissioner**) are also prescribed as designated local regulatory authorities under the Uniform Law.

The NSW Commissioner is the designated local regulatory authority in relation to complaints about lawyers (Chapter 5) and complaint investigations (Chapter 7). The NSW Commissioner has delegated functions to the Law Society Council including by an Instrument of Delegation and Direction dated 30 September 2020.

Section 28 and 32 of the Application Act allows the Law Society Council to delegate its powers and functions including:

- i. functions under Chapter 5 of the Uniform Law as delegated by the NSW Commissioner to the Law Society Council under section 28 of the Application Act;
- ii. functions under the Uniform Law (other than under Chapter 5), or within the instruments made under that Act, in respect of which the Law Society Council is the designated local regulatory authority;
- iii. functions under the Application Act, or within the instruments made under that Act, in respect of which the Law Society Council is the designated local regulatory authority.

# INSTRUMENT OF DELEGATION AND GUIDELINE UNDER SECTION 408

# 1. In this instrument:

- (i) Terms used in the *Legal Profession Uniform Law* (NSW) (**Uniform Law**) or in the *Legal Profession Uniform Law Application Act 2014* (NSW) (**Application Act**) or any subordinate instrument have the same meaning in this instrument as they have in those laws.
- (ii) Provisions means sections, rules, regulations or clauses.
- 2. Pursuant to section 32 of the Application Act and section 406 of the Uniform Law, the Council of the Law Society of New South Wales (**Law Society Council**) hereby delegates the powers and functions in the provisions specified in Column A and described in Column B of Schedule 1 to:

- (i) the Committee or Committees of the Law Society Council established pursuant to a resolution of the Council, or pursuant to a Constitution in respect of that Committee adopted by resolution of the Council, as specified in Column C; and/or
- (ii) the person or persons for the time being holding, acting in, or performing the duties of the position or positions specified in Column C, being employees of the Law Society of New South Wales.

Note: Headings used in Schedule 1 do not form part of the delegations

- 3. For the avoidance of doubt, and unless otherwise stated, the powers and functions delegated are all powers and functions exercisable under each provision specified in Column A.
- 4. The descriptions in Column B do not limit the scope of the powers and functions delegated in Column A.
- 5. Pursuant to s 408 of the Uniform Law, the Law Society Council may issue guidelines to its delegates about the exercise of functions under the Uniform Law or the Legal Profession Uniform Rules made under Part 9.2 of the Uniform Law. In the exercise of that power, the Law Society Council hereby issues the guidelines in Column D to the delegates specified in Column C, in respect of the exercise of any power or function specified in Column A.
- 6. This instrument does not affect the validity of any past act or past exercise of powers or functions exercised or performed in accordance with previous delegations or directions.

### **DELEGATION TO THE FIDELITY FUND COMMITTEE - 19 JANUARY 2023**

### The Council **RESOLVES**:

. . . . .

- 3. Pursuant to section 119(1) of the Application Act, the Council delegates to the Management Committee of the Legal Practitioners Fidelity Fund as constituted from time to time, the following functions of the Council in relation to the Fidelity Fund:
  - (a) the functions contained in sections 118 and 122(2), (3) & (4) of the Application Act:
  - (b) the functions contained in Part 4.5, Divisions 4,5,6 & 7 of the Legal Profession Uniform Law (NSW) (**LPUL**), but excluding section 240(1);
  - (c) the functions contained in Part 4.5 of the Legal Profession Uniform General Rules 2015 (the **General Rules**); and
  - (d) to take any action incidental to any of the above functions which might be required for the management of the Fidelity Fund in accordance with Part 9 Divisions 1 & 2 of the Application Act, Part 4.5 of LPUL and Part 4.5 of the General Rules.
- 4. Claims against the Legal Practitioners Fidelity Fund are to be determined by the Management Committee of the Legal Practitioners Fidelity Fund independently, at arm's length from the legal profession as required by section 240(1) LPUL.
- 5. Pursuant to section 119(1) of the Application Act and s.426(1) of the Legal Profession Act 2004 (**LPA 2004**) as applicable, the Council delegates to the Management Committee of the Legal Practitioners Fidelity Fund as constituted from time to time, so much of the functions previously delegated by the Council to the Management Committee of the Legal Practitioners Fidelity Fund in paragraph numbered 3 of its resolution made on 15 January 2015 as are necessary to give effect to clauses 22(2) and 2(5) of Schedule 4 of LPUL to deal with claims in accordance with LPA 2004.

#### INSTRUMENT OF DELEGATION

## Preamble: the role of the Council of the Law Society of New South Wales under the Legal Profession Uniform Law (NSW)

The Council of the Law Society of New South Wales (**Law Society Council**) is a designated local regulatory authority under the *Legal Profession Uniform Law* (*NSW*) (**Uniform Law**).

A designated local regulatory authority means "a person or body specified or described in a law of this jurisdiction for the purposes of a provision, or part of a provision, of this Law in which the term is used" (s6 of the Uniform Law).

The Uniform Law confers powers and functions on designated local regulatory authorities.

Section 11 of the *Legal Profession Uniform Law Application Act* (**Application Act**) sets out the provisions under the Uniform Law for which the Law Society Council is the designated local regulatory authority such as Chapters 2 to 4 and 6 to 8.

The Council of the Bar Association of New South Wales and the New South Wales Legal Services Commissioner (**NSW Commissioner**) are also prescribed as designated local regulatory authorities under the Uniform Law.

The NSW Commissioner is the designated local regulatory authority in relation to complaints about lawyers (Chapter 5) and related provisions. The Acting NSW Commissioner has delegated these functions (including certain related provisions) to the Law Society Council by an Instrument of Delegation and Direction dated 31 March 2023.

Section 28 and 32 of the Application Act allows the Law Society Council to delegate its powers and functions including:

- i. functions under Chapter 5 of the Uniform Law (including functions under Chapter 7 of the Uniform Law and functions under the *Legal Profession Uniform General Rules* relating to Chapter 5) as delegated by the NSW Commissioner to the Law Society Council under section 28 of the Application Act;
- ii. functions under the Uniform Law (other than under Chapter 5), or within the instruments made under that Act, in respect of which the Law Society Council is the designated local regulatory authority;
- iii. functions under the Application Act, or within the instruments made under that Act, in respect of which the Law Society Council is the designated local regulatory authority.

# INSTRUMENT OF DELEGATION AND GUIDELINE UNDER SECTION 408

### 1. In this instrument:

- (i) Terms used in the *Legal Profession Uniform Law* (NSW) (**Uniform Law**) or in the *Legal Profession Uniform Law Application Act 2014* (NSW) (**Application Act**) or any subordinate instrument have the same meaning in this instrument as they have in those laws.
- (ii) Provisions means sections, rules, regulations or clauses.
- 2. Pursuant to section 32 of the Application Act and section 406 of the Uniform Law, the Council of the Law Society of New South Wales (**Law Society Council**) hereby

delegates the powers and functions in the provisions specified in Column A and described in Column B of Schedule 1 to:

- (i) the Committee or Committees of the Law Society Council established pursuant to a resolution of the Council, or pursuant to a Constitution in respect of that Committee adopted by resolution of the Council, as specified in Column C; and/or
- (ii) the person or persons for the time being holding, acting in, or performing the duties of the position or positions specified in Column C, being employees of the Law Society of New South Wales.

Note: Headings used in Schedule 1 do not form part of the delegations

- 3. For the avoidance of doubt, and unless otherwise stated, the powers and functions delegated are all powers and functions exercisable under each provision specified in Column A.
- 4. The descriptions in Column B do not limit the scope of the powers and functions delegated in Column A.
- 5. Pursuant to s 408 of the Uniform Law, the Law Society Council may issue guidelines to its delegates about the exercise of functions under the Uniform Law or the Legal Profession Uniform Rules made under Part 9.2 of the Uniform Law. In the exercise of that power, the Law Society Council hereby issues the guidelines in Column D to the delegates specified in Column C, in respect of the exercise of any power or function specified in Column A.
- 6. This instrument does not affect the validity of any past act or past exercise of powers or functions exercised or performed in accordance with previous delegations or directions.
