TIPS FROM OTHER EARLY **CAREER LAWYERS**

Q. What is the one thing you wished you had known before moving to the region?

- Call the senior practitioners with any issues you might be having. They are very accommodating and helpful in the area, and have a great rapport.
 - Country practice can be difficult and diverse, and if things don't go to plan, it can impact you in small towns. I encourage you to lean on your colleagues and have interests outside of work.
 - Look after yourself and your mental health.
 - Get involved in meeting people from a social perspective.

What is the best kept local secret?

- In the Eastern Region such as Armidale, Glen Innes, and Tenterfield - you need good heating, cooling is not so much an issue.
 - In the Western Region such as Tamworth, Gunnedah, Narrabri, and Moree - the summers are scorching, you need reverse cycle A/ C and a pool or pool membership. In winter you need insulation and good heating!
 - Tamworth, Armidale, and Moree are all a one-hour flight from Brisbane and Sydney and only a 2-hour flight from Melbourne.
