




# GUIDE TO LIVING AND WORKING IN THE ORANA REGION

## GETTING INVOLVED WITH THE YOUNG LAWYERS OF THE ORANA LAW SOCIETY

All lawyers in their first five years of practice or under 36 years of age are eligible to receive NSW Young Lawyers communications.

If you reside in the Orana region you are considered a young lawyer of the Orana Law Society.

## CONTINUING PROFESSIONAL DEVELOPMENT

Lawyers are required to complete Continuing Professional Development (CPD) courses each year.

The CPD year runs from 1 April to 31 March the following year. You are required to complete 10 CPD units during the year.

You must have one of the following every year:

1. Ethics and Professional Responsibility;
2. Practice Management and Business Skills;
3. Professional Skills; and
4. Substantive Law.

The Orana Law Society hosts CPD events throughout the year. If you are unsure when the next CPD event is being held, contact the Orana Law Society CPD Coordinator or the Young Lawyers Representative.

### SOLICITOR OUTREACH SERVICE

The Solicitor Outreach Service is a confidential counselling service for NSW solicitors. This service is funded by the Law Society of New South Wales but is operated entirely by an independent third-party provider, and solicitor usage is not identified by or reported to the Law Society, to solicitors' employers, or to any other party. The Solicitor Outreach Service provides solicitors with access to:

- Up to three free individual counselling sessions per financial year with a registered psychologist; and
- Unlimited 24/7 telephone crisis counselling with a registered psychologist.



## TIPS FROM OTHER YOUNG LAWYERS

We asked a number of young lawyers from the Orana Regional Law Society what their tips are for other young lawyers moving to the Dubbo Region.

### Q. What is the one thing you wished you knew before moving to Dubbo?

- A.
- There will be 2 degrees of separation from everyone; I didn't realise how welcoming everyone was in all aspects of the town.
  - The summers get very hot and winter mornings can be very cold!
  - There was a mouse plague, so I'd keep your house clean!
  - The locals think anything "over the bridge" is too far away.

### Q. What is the best kept local secret?

- The cinnamon cruffins from Village Bakehouse – unreal!
  - You can get into the Old Dubbo Gaol for free if you have a Dubbo postcode on your licence!
  - There is great Friday night live music and happy hour at the Old Bank (and Muso's night every Tuesday)
  - Narromine Soul Food Depot for brunch or cheeky coffee on your way to Court out West
  - Friday afternoon and Sunday sessions at the South Dubbo Tavern. Get a locals pass for the zoo – only \$38 annually and you can go back as many times as you like!


